Marda Loop BIA

- Major revenue sources include BIA Levy, Marda Gras, City Grants. Some of the benefit of the City grants flowed into 2024 via pre-purchasing
- Major expense categories; Marketing & Events, Street Maintenance and Décor, Administration, and Marda Gras
- Surplus of ~\$10K in 2023 and unrestricted net assets grew to ~\$194K
- BIA Financials are audited by a CPA and have been submitted to City of Calgary
- No questions or objections

Festival Society of Marda Loop

- Status of Marda Loop Festival Society, account is current but inactive
- Festival Society financials are reviewed by two members per the Societies Act.
 - Thanks to Dr Brady Turner of The Eye Gallery and Charmain Chen of Marda Loop Braces
- MOTION: to accept the Financials of the Marda Loop BIA and the Festival Society of Marda Loop; Nova Kane (ATB) moves, Whitney Titheridge (Crabapple Clothing) seconds; carried
- MOTION: to enable the Board of Directors to appoint the Auditors of the Marda Loop BIA and the Festival Society; Nova Kane moves, Shannon MacNaughton (Slow Burn Books) seconds; carried
- 2024 Retrospective: Doug Anderson
 - BIA expansion to 17th Street complete



- Main Streets construction; update on progress and challenges, and ML-BIA work to mitigate impacts particularly through: Marketing, Promotions & Events, Litter and graffiti control
- Despite ongoing construction, BIA membership grown from ~175 in to ~200 businesses.
 Despite losses, speaks positively to the future
- Strategic Planning and engagement with Members on next steps in 2025

<u>Looking ahead to 2025</u>: Whitney Titheridge

- Completion of Main Streets in the business district by fall
- Continue to build on success of signature events, marketing initiatives, newsletter signups, and social media growth
- With Main Streets construction moving to completion, attention pivots to Streetscape:
 - New planters
 - Lighting opportunities
 - New banners
 - o Public art
 - Promoting Marda Loop history as part of our story

Engagement with members on next steps for the BIA

• 2024 Budget Review: Nova

- ullet Some costs higher than budgeted, but overall spending expected to be $^{\sim}$ \$11K less than budgeted
- 2024 budget projections called for significant withdrawals from unrestricted net asset (UNA) reserves in order to maintain levy rate and support efforts in the area during construction
- Expected UNA ~\$123K by year end

• 2025 Budget Planning:

- The 2025 Summary Budget was presented for information
- No changes to the levy, no increase since 2019
 - BIA tax rate should remain similar
- Looking at event sponsorship and grant opportunities to increase revenues
- Pull additional reserves from UNA to support:
 - Events and Marketing during final months of construction
 - Pivot to focus on Streetscape items
- Will still leave about \$50K in reserve by 2025 Year-End
- Engagement with members on future priorities
- Questions from floor answered to satisfaction
